Note: In creating this framework for evaluating the efforts of digital social platforms, we weighted enforcement more heavily than policy and explicit policies more heavily than general policies. Additionally, because no platform had affirmative results in every category, we did not award any platform an "A."

ONLINE HOLOCAUST DENIAL REPORT CARD

ADL recently evaluated 10 major digital social platforms on their efforts to effectively address Holocaust denial content on their platforms. The results of this investigation aim to encourage further research and investment by tech platforms in order to better address the spread of Holocaust denial.

One noteworthy finding is platforms with explicit Holocaust denial policies did not necessarily do better enforcing those policies against reported content. This raises questions about what makes for an effective platform policy—does expanding platform rules to include a longer list of specific phenomena result in a meaningful change for targeted communities? Our investigation cannot answer this broad question, but it urgently requires a more definitive answer.

In response to the attack on the U.S. Capitol and in an effort to address the overall increase in domestic terrorism, while protecting civil liberties, ADL announced the PROTECT Plan. NEW JERSEY HOMELAND SECURITY AND STATE PREPAREDNESS - DOXING AND SWATTING BILL

ADL NY/NJ has been working with the NJ Attorney General's Office since the implementation of the Youth Bias Task Force. As part of the recommendations of the Task Force a bill was introduced in the Assembly Senate to address a number of issues.

- The bill would add three preexisting cyber-related offenses to New Jersey's ethnic intimidation statute (hate crime), including the crime of initiating a "false public alarm" also known as "swatting."
- A.4833 would ensure that "mixed motive" hate crimes are covered
 under New Jersey law. If, for example, a suspect vandalizes a
 synagogue because of a deep hatred towards Jews, but also because
 he is angered by the amount of traffic that the synagogue brings to his
 neighborhood, it is critical that this incident be treated as a hate crime.
- The bill would ensure that "associational" hate crimes in other words, crimes in which a victim is attacked not because of the victim's own protected characteristics, but because of their association with a person or group who has or is perceived to have those characteristics are covered under New Jersey law.
- We are pleased to see that A.4833 would expand the crime of cyberharassment to include doxing—the posting of private or identifying information about an individual, group or organization with the intent that the information be used against the target for an unlawful purpose.

ADL NY/NJ AND NJ NAACP VIRTUAL MOU SIGNING

On February 3rd, ADL NY/NJ and the New Jersey NAACP commenced the second phase of a multi-year partnership working to fight hate against the rising tide of hate crimes and discrimination facing marginalized communities in New Jersey. The partnership is rooted in shared values between ADL and the NJ NAACP: opposing hate and discrimination; promoting safe and inclusive communities; and protecting people's civil rights. The agreement was signed by Richard Smith, President of NJ NAACP, and Scott Richman, ADL's NY/NJ Regional Director.

As part of the partnership, ADL NY/NJ and the NJ NAACP will launch a series of town halls and listening sessions throughout New Jersey to raise awareness about the organizations' collaboration and the importance of identifying and reporting bias-related incidents. The campaign will also work to build bridges of acceptance and understanding among ADL and NAACP constituents, and respond with a united voice to racism, antisemitism, and all forms of hate in New Jersey.
