NEW PARTNERSHIP TO COMBAT ANTISEMITISM AND HATE

ADL is joining forces with the Union for Reform Judaism (URJ), which represents the largest and most diverse Jewish movement in North America, to provide Reform congregations with tools to address antisemitism in their communities.

The partnership will connect ADL's expertise with URJ's resources to increase prevention and response to antisemitic attacks. It also includes the introduction of a [new online incident reporting form](#) tailored specifically to Reform congregations, collaboration around advocacy, and educating youth about antisemitism.

EXTREMIST AND HATE GROUPS ABUSING NON-PROFIT STATUS

A number of extremist and hate groups are currently registered as tax-exempt organizations with the IRS, allowing them significant financial benefits. To explore how extremist groups are exploiting tax-exempt status, ADL reviewed filings of over 30 groups listed as tax-exempt organizations, including groups associated with the Capitol insurrection.
