

## **ADL JOINS AS CO-COUNCIL IN D.C. LAWSUIT TO HOLD JANUARY 6 INSURRECTIONISTS ACCOUNTABLE FOR THEIR ACTIONS**

ADL joined with D.C. Attorney General Karl Racine, States United Democracy Center, Paul, Weiss, Rifkind, Wharton & Garrison LLP and Dechert LLP in filing a federal lawsuit to hold two violent groups accountable for the role they played in planning and carrying out the deadly January 6, 2021 attack on the U.S. Capitol.

The lawsuit specifically claims the groups - including their leaders and members - caused extensive damage to the District of Columbia, particularly to the law enforcement officers who risked their lives to defend the Capitol, the Congress men, women and staffers in the Capitol that day and our democracy.

## **NEW ADL REPORT: THE ANTI-ISRAEL MOVEMENT OF U.S. CAMPUSES, 2020-2021**

ADL's new report "[The Anti-Israel Movement on U.S. Campuses, 2020-2021](#)" provides a detailed assessment of anti-Israel actions occurring on campuses nationwide, including that much of the anti-Israel activist movement continued to vilify Israel and Zionism and ostracize pro-Israel and Zionist students. This action disproportionately impacts large percentages of Jewish students, for whom a connection with Israel is an integral component of their religious, social, or cultural lives and identities.
