### ANTI-LGBTQ+ HATE & EXTREMISM INCIDENTS: 2022-2023

ADL and GLAAD have released a first-of-its-kind report tracking extremist and non-extremist acts of harassment, vandalism and assault motivated by anti-LGBTQ+ hate. The report identifies more than 350 incidents of these kinds over an eleven-month period beginning in June 2022, directly coinciding with a disturbing increase in anti-LGBTQ+ rhetoric and legislation.

### ONLINE HATE AND HARASSMENT: THE AMERICAN EXPERIENCE 2023

ADL's Center for Technology and Society just released its annual Online Hate and Harassment report, which surveys thousands of people about their experiences with hate and harassment online. More than half of all American adults (52 %) have reported experiencing online hate or harassment in their lifetimes. This is the highest rate since 2020.
